## **Range Safety Officer (RSO) Service Agreement**

Archery Solutions (AS) hereby agrees to provide archery use access to building and/or land, equipment, supplies, or materials, which is always subject to direct supervision of a National Field Archery Association (NFAA) certified archery instructor. Said NFAA archery instructor will supervise range activity in the capacity of a Range Safety Officer (RSO).

By entering this agreement to supervise range events and/or participants using AS property as an RSO, I agree:

1. I will serve as a non-compensated volunteer when acting as an RSO on property owned by AS. I may or may not be compensated by other entities/individuals for events I supervise on AS property, but agree that I am acting as an independent contractor and not an employee of AS. And,
2. I will read, understand, and abide by AS range rules at all times while using property owned by AS. And,
3. I will verify that all participants using the range have read the range rules, and have signed and dated a Participant Waiver Form. It is the responsibility of the RSO to obtain a newly signed Participant Waiver Form or confirm that AS already has a form on file dated in this calendar year. A log book will be available on site to verify date and existence of previously signed Participant Waiver Forms. A drop box will be available on site in which to leave newly signed forms. And,
4. I will maintain a safe range environment and will devote my time and attention to safe use of the range by all person located on-site. I also agree to enforce all range rules while I am acting as RSO and when participating on AS property, whether acting as RSO or not. And,
5. I will notify an AS owner, or other designated person, immediately if damage occurs to AS building, land, or equipment. And,
6. I will notify an AS owner, or other designated person, immediately upon any personal injury of any participant, spectator, RSO, or other individual located on AS property. And,
7. I agree to maintain current owner contact information when acting as RSO on AS property. And,
8. I will collect applicable money per current posted rates or otherwise per participant contract, document the number of participants and applicable rates, and will leave money and supporting documentation in the drop box on site. To extend you are allowed to use the property on your own time, you will not allow others to shoot with you without paying applicable rates. I also agree to abide by the RSO pricing guidelines most recently approved by the management board.
9. When possible, to assist/teach/coach participants when assistance might improve their skills and/or help them to enjoy their participation in archery sports.
10. I will complete a Participant Waiver Form in addition to the RSO service agreement if I use AS property as a participant.

RSO agrees to hold AS harmless from any and all claims arising from the use of AS property while serving as RSO. This is true of liability claims and property damage that may occur. RSO is responsible for using property in a safe manner consistent with its intended use.

By signing this agreement, RSO agrees to the terms herein. AS signer warrants that he/she has the authority to execute this contract.

### **RSO Pricing Guidelines – Draft for Management Board Approval**

As of January 1, 2015

RSO will be defined as a currently licensed NFAA Instructor in good standing who has agree to supervise range activities for at least 60 hours in a calendar year. An RSO will get supervisory credit when they have been designated an RSO for an event and sign the collection worksheet as the designated RSO. Generally, we will have one designated RSO for each league night unless we have more than 35 participants. For adult events, we will have one designated RSO for every 25 participants. If event or league sponsors have more restrictive guidelines, then the more restrictive guidelines will apply. The owner and/or management board have discretion to give RSO credit for volunteer time in addition to the above guidelines.

RSO will pay the same event and league fees as participants when participating in leagues or events.

RSO will pay the following rates for shooting outside of events and/or leagues on personal time. The rates apply only to the RSO. Friends or family shooting with RSO will pay normal published rates. RSO is responsible for collecting and remitting collections the same day as shooting.

- Paper targets and paper target butt use will be at no cost.
- 3-D target use will be at \$8 for up to four hours.
- Broadhead target use will be at \$10 per hour.
